**Regarding Contribution to Trademark East Africa Strategy II: Burundi Country  
Programme**

Reference is made to the above Delegate Cooperation Agreement (DCA) for the above programme signed by DFID and Belgium (the Donors) on the above mentioned dates. The Amendment to DCA outlined below follows the recent discussions between the two Governments about the TMEA Burundi programme exchange loss.

**Now, THEREFORE, the Donors agree to delete the text within paragraphs 4 and 5 of the original DCA and replace with:**

"4. DFID will request payments using Annex 1, in accordance with the payment schedule as detailed in paragraph 5 and provide the Kingdom of Belgium with supporting documentation. Payment will be made into:




