Re: IOM - Belgian voluntary multiannual unearmarked contribution to the operational budget of IOM 2021-2014

Dear Mr. Vitorino,

I have the pleasure to inform you that the government of Belgium, through its Federal Public Service of Foreign Affairs – Directorate-General for Development Cooperation (DGD) has foreseen a voluntary multiannual unearmarked contribution of 4.000.000 EUR for the period 2021-2024 as a financial contribution to the operational budget of IOM. This contribution also includes the maximum amount of 200.000 EUR for the period 2021-2024 as a financial contribution to the support unit for the Global Forum on Migration and Development.

These funds will be paid in four annual installments of 1.000.000 EUR in 2021, 2022, 2023 and 2024.

1. Payment

The disbursement of the first installment of 1.000.000 EUR will be made after your acknowledgement of receipt of this letter. Subsequent disbursements in 2022, 2023 and 2024 will be made upon receipt of an annual payment request. Your letter should include a payment request which mentions:

- the exact amount of the contribution in EUR
- a payment reference
- the complete bank account information.

2. Administration of the contribution

The contribution shall be used for any planned activities under the regular budget and strategic plan of IOM, including an earmarked contribution for the support unit of the GFMD.

The contribution shall be administered by IOM in accordance with its financial regulations. Procurement of goods and services shall be done according to the rules and regulations of IOM.

3. Justification and reporting

IOM shall justify the use of the funds within the framework of its global financial reporting system to the Member States and the donor community, and through the Council of IOM and the Standing Committee on Programmes and Finance.

The contribution shall be subject exclusively to the internal and external auditing procedures provided for in IOM's Financial Regulations and Rules, and other applicable directives of IOM.

IOM shall also submit an annual progress report, again within the framework of its overall reporting responsibilities to the Member States.

The GFMD shall justify the use of the funds to IOM according to GFMD rules and procedures.
