 Phases II and III were completed in 2015 and therefore do not need an Annual Results report.
- Key issue nr.2: Final Reports of projects II + III A copy of Final Reports of phases II + III of the project have been signed by the National Project Director and BTC Technical Adviser. The Steering Committee Members approved this report in June 2015 provided that information on the balances under these two phases be given.
